Notes to the Financial Statements
For the year ended 31 December 2011

1. Incorporation and Activities

a. Incorporation

Imdad-Sitara Khan Foundation was an initiative under the Khan Family Foundation established by Dr. Imdad Haque Khan and his spouse Mrs. Sitara Khan with the aim of providing generous services to the concern and started its operation by helping people with kidney dialysis. Later on the same initiative, the Imdad-Sitara Khan Foundation, has been registered as a Society on 27th March 2007 under the Societies Registration Act, 1860.

b. Activities

Under the principal objects of the initiative, it has established kidney dialysis centres and is providing dialysis services to the people in need.

2. Significant Accounting Policies

Basis of Accounting

The financial statements have been prepared on a going concern basis under the historical cost convention on accrual method and in accordance with generally accepted accounting principles.

3. Operations during 2011

During 2011 the Foundation received Tk.32,928,490. After meeting revenue expenditure of Tk. 18,636,750 it transferred Tk. 14,291,740 to the ISKF Fund. Foundation also spent Tk. 12,202,379 from its Fund for fixed assets acquisition during the period. No depreciation was charged in 2011

5. Bankings

Foundation maintains bank accounts with Agrani Bank Limited, The City Bank Limited, Dhaka Bank Limited and Sonali Bank Limited. Closing balance at close of business on 31 December 2011 was Tk. 3,980,903.

6. Cash in Hand

Closing balance as at 31 December 2011 was Tk. 171,359.

4. General

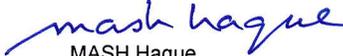

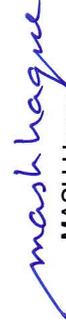

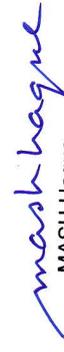
